2. 2020-21 Audited Financial Report

## Audited Financial Report

The President tabled the Audited Financial Report and noted a profit of \$9,859.35 for the 2020-21 financial year, with \$24,542.46 in assets at 30 June 2020. The President also noted \$689.70 in umpires fees and web domain fees was not booked until July 2020, so that the real result was an approximately \$9000 profit.

The President noted current assets of \$43,784.73 on 26 November 2021, reflected collection of fees while the vast majority of ground charges have not yet fallen due.

The President spoke to the result, noting that the Association received a windfall of approximately \$16,000 from the ACT Government not charging ground hire fees for season 2020-21 as a COVID relief measure. Consistent with a resolution of members at the 2020-21 AGM, this gain will be expended over three years by keeping fees lower than required to break even until the 2023-24 season.

For context, the President noted that if the Association had not received the windfall gain, the Association would have made an approximately \$7000 loss due to the discounted entry fees.

The President noted that the Association expects to make an approximately \$5000 or \$6000 loss this year due to the discounted entry fee for season 2021-22.

### Members approved the Audited Financial Report.

### Management of Funds

The President noted the increasing difficulties encountered in paying for services by cheque. The President noted that he would propose a resolution later in the meeting to alter the Constitution to allow payments for services through internet banking, subject to appropriate controls to minimise the risk of misuse of funds by office bearers with access to the bank account.

- 4. Scheduling

The President noted that due to the delayed start to the season resulting from COVID-19 restrictions the regular season would be 8 rounds. On top of the discount on fees calculated on the basis of an ordinary 9 round season, a refund reflecting costs foregone for playing 8 rounds will be worked out at the end of the season.

5. Scheduling: Christmas-New Year break

The President noted 26 December and 2 January are not scheduled as playing Sundays, although teams can request ground bookings for 2 January to fit in rescheduled matches.

11. IMB Bank sponsorship offer

The President reported that IMB Bank had approach the Association with a proposal the Association enter into a referral agreement with the Bank – that if members take out a residential or commercial loan and say the Association referred them then the Association receives a fee from the bank (not paid out of the loan).

Members approved the Committee considering the matter in detail and deciding whether to enter into an agreement on behalf of the Association.

## Motion carried unanimously

The President spoke to the motion, noting that the Association's key suppliers are increasingly not accepting cheques, now including ACT Sportsgrounds. To deal with this in the short-term, the President has been paying from his own funds and receiving reimbursement via cheques drawn on the Association. The President noted this is not a tenable long-term solution.

The President also noted that following the meeting an amendment to the Association's Constitution to reflect the motion will be drafted and circulated by email for approval in writing.

#### 13. Other Business

#### **Discussion of playing conditions**

#### *Length of matches*

The President discussed the issue of matches running past 6pm, and invited comments on ways to address the issue. Members noted the most common factor in matches running past 6pm is a late start to the second innings. Members recommended the Committee develop a rule change to bring to the next AGM that the first innings cease at 3.15pm (if the innings is not already concluded), with the number of overs bowled in the first innings being the number of overs to be bowled in the second innings.

#### LBW rule

The President also invited discussion on the LBW rule, noting that some similar competitions in Melbourne have ceased to use the rule. Members discussed the pros and cons of trialling in one grade not using the LBW rule; the majority opinion was not to proceed with a trial at this time.
